- Wharf Demurrage Fees is not applicable on Quarantine held cars that AAT cleans at the Webb Dock West Terminal. AAT WDW will charge storage, as normal if the cars are left in the terminal once cleaned and released ready for delivery.
- Charges are payable on all cargo (including all Customs held cargo) delivered >120 hours prior to vessel loading for export cargo.
- Free time is calculated from vessel ETA/ATD.
- Failed shipments will attract 50% of the daily listed demurrage rate calculated from Cargo Gate In until Cargo Gate Out.
- All accounts must be settled before cargo will be released.
